This paper focuses upon the impact upon recent socio-political processes of irrationality, as it is commonly displayed by essentially “normal” persons – with a particular focus on enabling youth to understand social functioning and dynamics, and to become active and effective contributory members of society.*

medical-legal system regarding patients with acute PTSD who had also suffered previous trauma

*In many cases, taking a comprehensive history reveals that the patient presenting with acute post-traumatic symptomatology has experienced traumatization in the past. Exploration at times reveals that these patients suffered previously diagnosable episodes of Post-Traumatic Stress Disorder, for which they may or may not have received significant or partial mental health treatment; but very often, they were never before evaluated, diagnosed or treated, and they relied on their own reasonably adaptive personality traits and psychological defenses to overcome the emotional impact of the prior incidents. At times, the emotional consequences of previous trauma were “reasonably” worked through, but more often than not, earlier episodes of trauma were merely repressed or suppressed and never actually resolved. Often, those issues have been contained by denial, rationalistic defenses, dissociative repression, a tendency towards social avoidance, or becoming involved in a rather dependent relationship (benign or malignant) which had been perceived as (superficially) offering “protection”. While those defenses may function “well enough” for years, it is not unusual that a further acute trauma disrupts those defenses, and what then emerges are affective symptoms and emotional conflicts which conflate issues arising from the acute situation with long-repressed unresolved factors.*

### **“Social Irrationality”**

Chaired a panel and presented a paper [follow-up to 2007 presentation] on using a model of characterological dynamics to understand the political system, with a specific focus on the November, 2008 Presidential election process.

*In close elections, including 2008, not only is the ultimate result often very heavily weighted to the last-minute irrational emotional reactions of a relatively small percentage of the population, but informed and sophisticated campaigns on both sides of the political spectrum understand this (on a practical level, even if not on a deeper psychological level), and thus, the campaigns are largely “managed” to solidify the base and “logical” voters early on, and then in the closing months or weeks, to attract the emotionally-driven “undecided” voters. This phenomenon significantly impacts the entire positioning and strategy of the campaign, and even the selection of candidates, as well as the “attitudes” “spin” and “persona” that the candidates and campaigns adopt.*

### **“Conflicts of Interest in the California Workers Compensation System”**

Presentation on mental health professionals’ inherent therapeutic conflicts of interest resulting from the regulations established by current California Workers’ Compensation Law.

*There have been multiple significant changes to California Workers Compensation Law over the past two decades – 1993; 2003, and most recently, 2006 (changes which became effective between July, 2006 and January 1, 2007). As the system now stands, in my opinion, physicians are placed into positions of inherent conflicts of interest in several different areas of the medical-legal evaluation and treatment.*

#### **“Integrated Co-Therapy”**

Interventions by psychiatrists and non-psychiatrists are frequently independent and un-integrated; however, optimally effective treatment requires a close collaboration between the psychiatrist and non-psychiatric therapist regarding both psychotherapeutic and psychopharmacological issues. I have developed a **protocol of integrated treatment that can be used to facilitate the eclectic use of interventions and treatment modalities**. This methodology can be particularly effective for dealing with “difficult” patients (e.g., borderline

pathology and severe PTSD) and for cases when there is a necessity to also address practical medical-legal issues such as disability status, limitations, and accommodations.

### **“An Introduction to Psychiatric Training”**

The comprehensive evaluation of emotional and behavioral symptomatology must take into account phenomena arising out of complex interactions between endogenous physiological/neuro-biochemical factors, as well responses to life circumstances and work/personal problems, social issues, existential issues, and physical pain or medical illness. The outline developed is a **“decision-tree flow chart” for performing an initial psychological evaluation using an integrated standpoint**. It may be used by mental health professionals–in-training and non-mental health clinical evaluators to more effectively develop and advise a course of intervention appropriate to a particular patient.

### **“Madness, Irrationality, and Psychopathology – A Construct of Psycho-Social Phenomena from a Psychiatric Developmental/Characterological Viewpoint”**

*Having come to psychiatry after training as a chemical and bio-medical engineer, I developed what I have found to be a practical schema describing personality dynamics, psycho-social functioning, and related pathological phenomena. Beyond addressing the clinical issues of the evaluation and treatment of mental health patients (beyond simply providing psychopharmacological intervention to suppress specific symptomatology), this same model can be applied to **evaluating and understanding interpersonal phenomena as they occur within society in general in various different milieu, including typical day-to-day interpersonal individual interactions, group behavior, workplace and business dynamics, and socio-political phenomena**. I have formulated a schemata of personality development, focusing upon the development of a person’s ability to relate maturely and effectively to others, the ability of a person to respond to external events and “stresses”, the and nature of the psychological defenses used by certain people/patients which interfere with mature functioning as full participants in all aspects of society. These issues are described without resorting to technical jargon or esoteric theory.*
